

## PVM China X1 or X 2 Visa Application Overview

**Preliminary Review Process:** China now requires an online submission of all applications where a review of your application and required documents will be conducted. During this time, the Embassy will either approve your application or request additional information. PVM works with our clients to get approved without additional Embassy requests. Visas are typically issued as a 10 year multiple entry visa, however they maintain it is at their discretion. The embassy may ask for additional information during the submission phase which can delay the process.

**What our fees cover:** Fees cover the Consulate fees, PVM service fees, and secure courier transit between our Florida and Washington D.C. offices.

- **Home Delivery:** Shipping to your residence is an additional cost; specific options are provided in our questionnaire.

## **PVM China Visa Procedures & Requirements (2026)**

**Requirements & Procedures:** Email high-quality scans of all documents along with this completed PDF to [info@passportsvisasandmore.com](mailto:info@passportsvisasandmore.com) or visit our website to schedule an appointment. We also work with travelers who would like full remote assistance rather than come in person.

- **Expert Review:** We offer comprehensive document audits via email or in person. Requests for email reviews are confirmed within 2-3 business hours (Business hours are from 9 AM to 5 PM). After our review we will follow up with a detailed list of any missing documents or instructions to book an appointment. In person

reviews provide expert assessment of your physical documents to ensure compliance before submission but require an appointment.

- **Flexible Service:** We offer in-office appointments in **Miami and Orlando**, or **remote assistance** via FedEx for travelers who are unable to come in person.

### 1. Completed Application Form (Form starts on page #4)

- **No Blanks:** Every field must be filled where applicable, including trip details, your education (even if it was abroad) and your parents' details.

### 2. Proof of Citizenship & State Residency

- **Passport:** Scan of the signed information page of the passport. You must have 6+ months validity from your return to the United States.
- **Scan of Blank "Visa" Passport Pages:** Embassy will require a scan of blank "VISAS" pages showing your passport has the capacity to support the visa.
- **Jurisdiction Proof:** A scan of your **State Driver's License or ID**. If your license does not fall in the DC jurisdiction, you can provide a **Utility Bill** (Water/Electric), **bank statement or lease agreement** in your name proving DC jurisdiction.

### 3. Letters of Invitation

- **Copy of the student JW invitation letter bearing the bar code application ID number on the top left hand corner and the QR code on the top right hand corner.**
- **Acceptance Letter from the School on the School letterhead bearing the Chinese red seal of the school**

### 4. Passport Photo, Previous Visas & Other

- **Photo:** One digital JPEG/JPG. Must be taken against a **flat white wall** from the middle chest up, meeting U.S. passport standards. Photo requires your hair must clear your forehead, no smiling or showing of teeth. **PVM can take your photo at no additional cost in our offices.**
- **Previous Chinese Visas:** If you state that you have had a previous visa for China, a scan of your most recent Chinese visa is required. If unavailable, a signed letter of explanation is required by the Embassy.
- **Special Travel History Letter if you have entry stamps into Turkey, Kenya, or Nigeria.**
- **Applications for minors will require a copy of their birth certificate**
